

## New England Revolution / Midnight Riders Code of Conduct

Fans are encouraged to cheer, sing and otherwise support their team while remaining respectful and courteous to their fellow patrons, referees, opposing team fans, players and coaches.

Unacceptable behavior may include but is not limited to the following:

- Acting in a violent or threatening manner to stadium staff or patrons
- Sneaking alcohol into the stadium
- Throwing or attempting to throw objects onto the field
- Refusing to cooperate with requests from Stadium staff
- Setting off fireworks or smoke bombs, whether in the stadium or in the parking lot (NOTE THAT FIREWORKS ARE ILLEGAL IN THE STATE OF MASSACHUSETTS).
- Using offensive language or obscene gestures, including using language or gestures referring to a person's race, ethnicity, color, gender, religion, creed, disability, age, sexual orientation, gender identity/expression or national origin; or instigating, inciting or encouraging a confrontation or physical contact.

Failure to obey these rules could lead to arrest, expulsion from the stadium and/or the Midnight Riders. Appropriate disciplinary action will be decided by a disciplinary committee consisting of Midnight Riders Executive Board members and Revolution staff.

In addition, for serious infractions, the following protocols will be followed.

1) Any Midnight Riders member responsible for actions, for which they receive a lifetime ban from Gillette Stadium, will have their membership status reviewed by the disciplinary committee. If the committee determines that the member did commit the offense in question, that member will be banned for life from the Midnight Riders.

2) Any person whose actions result in them being arrested by the police, will, if found to be responsible by the supporters group disciplinary committee, receive a one (1) year ban from the Midnight Riders for the first offense and a lifetime ban for the second offense.

3) Any person found responsible for actions for which they are removed from Gillette Stadium on a particular day, and who is reported to the Midnight Riders by the Revolution Front Office, will after review by the disciplinary committee, be banned for the year after the **second** such incident.

4) The Revolution Front Office must be informed if a person accused under the aforementioned protocols is in fact a member of the Midnight Riders, and what the outcome of the disciplinary hearing was.

Unacceptable behavior, as outlined above, by Midnight Riders members within stadium property will not be condoned nor covered up. In the event that these unacceptable behaviors are witnessed by members of the Midnight Riders, they must be reported to members of the Midnight Riders Executive Board or the disciplinary committee. If the Midnight Riders knowingly cover for someone's transgressions, the group could potentially be held liable for their actions.
